So far, the agreement—now in its final phase—has primarily been an institutional endeavor, shaped by diplomatic and governmental bodies over the years. Yet, it **still lacks the civil society structures** necessary for its full consolidation.

For such partnerships to achieve long-term success, civic society networks have to be consolidated among blocks. Beyond institutional agreements, they help build frameworks of shared meaning, knowledge exchange, and social interactions that governments alone cannot establish. These networks foster knowledge-sharing, social connectivity, business collaborations, cultural initiatives, and other essential dimensions of sociopolitical life—key elements in ensuring stable and enduring relations.

In this sense, to bridge the gap between governmental efforts and the essential role of civil societies, this project seeks to establish a bi-regional organization-network dedicated to strengthening the non-governmental dimension of the European Union-Mercosur partnership.

Its mission is to conduct related research, organize events on key topics relevant to the evolving agreement, and to contribute to solidify the biregional networks among other organizations and people.


#### New globalization
